**A BY-LAW TO AMEND THE FEES AND CHARGES BY-LAW (088-2017 And 046-2019) OF THE TOWN OF COBOURG, TO ADOPT THE COMMUNITY SERVICES DIVISION – WATERFRONT OPERATIONS - 2022 FEES AND CHARGES SCHEDULE**


**WHEREAS** pursuant to *Municipal Act S.O. 2001, c.25* Section 391 provides in part that a municipality may pass by-laws imposing fees or charges on persons for services or activities provided or done by or on behalf of it and for the use of its property including property under its control;


**AND WHEREAS** Council authorized the preparation of a by-law to amend the Fees and Charges By-law (088-2017) to adopt the Community Services Division's 2022 Fees and Charges Schedule at the Committee of the Whole Meeting held on December 6, 2021.

**NOW THEREFORE** the Council of the Corporation of the Town of Cobourg enacts as follows:

1. **THAT** the Schedule 'A' of the Fees and Charges By-law No. 088-2017 and By-law No.046-2019 be amended to adopt the revised fees and charges of the Community Services Division, Waterfront Operations Department as outlined in Schedule 'A' of this by-law.
2. **THAT** this by-law shall come into full force and effect upon the date of its passing.
